



History of Rawalpindi Medical University

Established on March 18, 1974, Rawalpindi Medical College (RMC) began in Faisalabad before relocating to Rawalpindi on November 5, 1974, initially in an incomplete building at Tipu Road, later fully handed over to RMC. Under the dynamic leadership of Prof. Abdul Latif, RMC flourished with the construction of essential facilities such as student hostels, staff accommodations, and an auditorium. Prof. Latif's vision led to the acquisition of the Holy Family Hospital and the transformation of the Central Government Hospital into what is now Benazir Bhutto Hospital, while also affiliating the District Headquarters Hospital as its first teaching hospital.

His successors continued to enhance RMC's stature, securing funding from the Islamic Development Bank to establish a New Teaching Block at the Holy Family Hospital and pioneering

the internationally acclaimed Psychiatry department. In 2007, RMC led the public sector with the establishment of the Department of Medical Education.

Prof. Mohammad Umar, RMC's first Rawalian Principal and current Vice Chancellor, initiated a comprehensive revitalization. His initiatives included restructuring the undergraduate training

through the Department of Medical Education, upgrading campus facilities like libraries, cafeterias, and hostels, and establishing the RMC park and Rawalians' facilitation center. Prof. Umar also played a pivotal role in shaping national guidelines for undergraduate medical training, underscoring RMC's leadership in medical education continuing its legacy of excellence and innovation as a premier institution in medical education healthcare, now continuing his



efforts for excellence and innovation to make RMU a premier institution in medical education and healthcare.

The current Principal of RMC is Prof. Dr. Jehangir Sarwar Khan, who is also a Rawalian and a renowned surgeon.

Infrastructure

Rawalpindi Medical University (RMU), located in Rawalpindi, Pakistan, is a prominent public-sector medical institution established in 2017. Formerly part of Rawalpindi Medical College, RMU has since evolved into a degree-awarding university dedicated to providing high-quality medical education, research opportunities, and healthcare services. RMU is affiliated with three major teaching hospitals: Holy Family Hospital (HFH), Benazir Bhutto Hospital (BBH), and District Headquarters Hospital (DHQ). These hospitals serve as vital clinical training grounds for RMU students, offering them exposure to diverse medical conditions and hands-on learning experiences under the supervision of experienced faculty.

Holy Family Hospital, the largest and most advanced of the three, specializes in maternal and child healthcare, offering services in gynecology, pediatrics, and neonatology. It is equipped with

modern diagnostic and therapeutic facilities, making it a hub for research and postgraduate training.









Benazir Bhutto Hospital, formerly known as Rawalpindi General Hospital, is a multi-disciplinary healthcare facility renowned for its emergency and trauma care services. It hosts various departments, including cardiology, nephrology, and orthopedics, catering to a high patient volume from Rawalpindi and surrounding areas.

Rawalpindi Teaching Hospital focuses on primary and secondary healthcare services. It supports RMU's mission by providing practical exposure in internal medicine, general surgery, and outpatient care.

The Pakistan Medical and Dental Council (PMDC), now replaced by the Pakistan Medical Commission (PMC), accredits RMU for its undergraduate and postgraduate medical programs. This accreditation ensures that RMU meets the rigorous academic and clinical standards required for training competent healthcare professionals in Pakistan. The university's adherence to PMC guidelines highlights its focus on delivering quality education that aligns with national healthcare needs.



RMU has also earned recognition from the Higher Education Commission (HEC) of Pakistan, which is responsible for overseeing and funding higher education institutions in the country. The HEC accreditation signifies RMU's compliance with quality assurance protocols, including faculty qualifications, research output, and infrastructure development. This recognition enhances the university's credibility and makes its graduates eligible for advanced studies and professional opportunities both domestically and internationally.

On the international front, RMU is listed in the World Directory of Medical Schools (WDMS), a global database that facilitates the recognition of medical schools worldwide. This listing allows RMU graduates to pursue postgraduate training, licensure, and practice in various countries, including the United States, the United Kingdom, and Canada. Moreover, RMU's inclusion in the International Medical Education Directory (IMED) and recognition by the Educational Commission for Foreign Medical Graduates (ECFMG) further solidify its global standing, enabling its students to participate in international medical examinations and residencies.

Additionally, RMU actively collaborates with international medical institutions and research organizations, further enhancing its reputation and educational standards. The university's focus on continuous improvement and alignment with global medical education trends ensures that it remains a top choice for aspiring medical professionals.

These accreditations not only validate the quality of RMU's academic programs but also enhance its graduates' prospects for successful careers worldwide. Through these affiliations, RMU continues to play a pivotal role in shaping the future of healthcare in Pakistan and beyond.

Admissions

For the admissions to the medical colleges of the province of the Punjab, the policy guideline of the Specialized Healthcare & Medical Education (SHC&ME) Department issued vide Notification No. So(ME-II)2-1/2025 dated 22nd October 2025 will be followed.

- 1. University of Health Sciences (UHS), Lahore, "Admitting University", shall conduct admissions to MBBS/ BDS courses of public and private sector Medical and Dental Institutions/ Colleges in Punjab for the Session 2025- 2026.
- 2. The merit determination formula for the Session 2025-2026 shall be as under:

F. Sc. (Pre-Medical)/HSSC/ Equivalent	40% weightage
Matriculation/ SSC/ Equivalent	10% weightage

3. The pass percentage and validity period of MDCAT shall be as under:

- 4. The eligibility criteria for admissions shall be:
 - a. has passed the MDCAT Examination;
 - b. has obtained a Higher Secondary School Certificate (HSSC) qualification or an equivalent 12th grade qualification recognized in Pakistan (IBCC Equivalence Certificate is mandatory in that case) and having obtained minimum 65% marks therein; and
 - c. has passed the subjects of Biology and Chemistry and either Physics or Mathematics in the examination of the Higher Secondary School Certificate Examination or an equivalent 12th grade qualification recognized in Pakistan.
 - * Provided that the mandatory requirement of MDCAT shall not apply to the candidates admitted on special program seat pre-defined exclusively for foreign students and on the seats reserved for Overseas (being a Pakistani citizen permanently resident in foreign country) Pakistanis, who have studied and passed HSSC 12 grade examination or equivalent from outside Pakistan. Such students shall qualify SAT-II with minimum score of 550 in each subject or a foreign MCAT examination or UCAT examination with 50% marks in each subject prescribed as stated supra in 4(C).
- 5. Hafiz-e-Quran Marks: The marks for Hifz-e-Quran shall not be granted for admission to Medical and Dental Colleges in the light of PM&DC Medical and Dental Undergraduate Education

(Admissions, Curriculum And Conduct) Policy and Regulations 2023 and the decision of six membered Bench vide Order dated 04.04.2023 in Suo-Moto case.

6. Students applying for admissions shall give an order of preferences for public and private sector Medical and Dental Colleges. In case of Private sector, there shall be no restriction on the number of colleges to be opted by a candidate. In case of public sector, the applicant has to choose all colleges in order of preference.

The application shall be editable till the closing date of submission; however; the number and order of preferences cannot be changed after last date of submission of on-line application. A college, not included in the preference list of students, shall not be considered for grant of admission / up-gradation.

- 7. Students admitted in private sector institutions may exercise the option to forego the right of upgradation at the time of joining an institution. The option once availed shall attain finality and shall neither be revoked nor modified at any subsequent stage.
- 8. The admission process shall be conducted through an on-line portal. The University of Health Sciences, Lahore shall charge a fee of Rs. 2000/- from each candidate applying for admission to public and private sector Medical & Dental Colleges in Punjab. Each candidate shall apply separately to a medical or dental program. A student having not applied to a given program shall not be entitled to admission to such program. The selected candidate shall deposit prescribed college fee within three (03) working days after the display of the merit list. The University shall prepare college-wise selection list(s) in accordance with merit- cum-preference of candidates through a fair digitalized system developed/ acquired by the University. The following procedures shall be followed:
 - a. Candidates shall deposit prescribed colleges fee in a dedicated bank account of the University (UHS). In case of failure to deposit the prescribed admission fee within stipulated time period, such candidates shall have no vested right of admission in that year.
 - b. Only those candidates shall be considered as admitted candidates who will "join" the program by (a) depositing the prescribed fee and other dues by due date, and (b) reporting (in writing) to their respective colleges by due date.
 - c. The deposited fee will be disbursed by UHS Lahore to the concerned colleges immediately after completion of admissions in designated bank accounts of concerned colleges by the UHS, Lahore.
 - d. The overseas Pakistanis if selected against the open merit seats, then they shall pay fee at par with the Pakistani students. However, if they are selected against quota seats reserved for overseas Pakistanis then they shall deposit fee in foreign currency i.e. 10,000 US Dollars per annum on self-finance basis in accordance with the PMDC Notification PF-1-C-PMDC- Notification/2024/741 dated 21-03-2025. The students admitted under the

- category shall complete the entire program of study under the same category. An undertaking/affidavit/ bond shall be provided by the student to this effect.
- e. The students selected against foreign quota seats shall deposit fee in foreign currency l.e. 10,000 US dollars in accordance with the PMDC students admitted under the category shall complete the entire program of provided by the student to this effect.
- 9. The cut-off dates for receipt of nominations from Federal & Provincial Governments and other Nominating Agencies/ Authorities for respective categories of seats shall be as under
 - For special category seats (PTAP & IIOJK): 31st Dec. 2025
 - For reciprocal seats only: 31st Dec. 2025
- 10. For all quotas excluding reciprocal seats, PTAP and IIOJK, the University of Health Sciences (UHS), Lahore shall accept applications directly from the students/ candidates of ICT, Gilgit-Baltistan, AJ&K, ex-FATA, Balochistan (both categories of ex-FATA, Balochistan seats including the HEC scholarship seats) in accordance with the prescribed criteria for the respective seats and the list of selected respective competent forum etc.

11. Display of Merit:

The admissions to public and private sector Medical & Dental Colleges shall be completed as per PM&DC schedule. The admissions in public and private sector Medical & Dental Colleges shall be completed after display of three or more merit lists by the University. The vacancies in second and subsequent merit lists shall be filled through the process of up-gradation, based on merit-cum-preference.

Domicile

- Domicile of the candidate is a mandatory document. The candidates having domicile of any district of Punjab are eligible to apply for admission against Open Merit, Under-Developed Districts, Students with Disabilities, Cholistan, and Reciprocal (for Punjabdomiciled candidates in other provinces/regions) categories of seats.
- Overseas Pakistanis/residents with dual nationality do not require a domicile for applying to their quota seats.
- For candidates applying on seats reserved for the students of Under-Developed Districts (Dera Ghazi Khan, Layyah, Rajanpur, Muzaffargarh, Lodhran, Mianwali, and Bhakkar) and Cholistan, it is mandatory to have a domicile of the relevant district. In the case of D.G. Khan and Rajanpur districts, candidates applying for tribal area-specific seats must have "Tribal Area" mentioned on their domiciles. Similarly, for Cholistan seat, candidates must have "Cholistan" mentioned on their domicile certificates.

Age Limit

There is no minimum or maximum age limit for admission to a medical and dental college.

Procedure and Conditions of Admission

Candidates are advised to consult the documentation available at the admission portal of University of Health Science's website www.uhs.edu.pk for details and policies related to

Submission of Mandatory Documents for Admission

• Domicile Certificate:

The Punjab Domicile is a mandatory document for candidates.

Educational Documents and Their Attestation:

- i. Candidates are required to have the photocopies of their SSC and HSSC (Pre-Medical) result cards attested/verified by the relevant Board of Intermediate and Secondary Education. In case of IBCC Equivalence Certificate already issued, get it attested by the IBCC. These attested documents must be scanned and uploaded on the MBBS/BDS admission portals. For HSSC-pass candidates, attestation by the Inter-Board Coordination Commission (IBCC) is not required at the time of admission. However, after admission to a medical or dental college, candidates will be required to have their educational documents attested by the IBCC upon joining their respective institutions
- ii. Candidates with foreign educational qualifications (such as A-levels, IB, American/Canadian 12th grade, etc.) must submit an Equivalence Certificate or Provisional Equivalence Letter for the equivalent educational qualification of their 10th and 12th grade examinations, issued and duly attested by IBCC.
- iii. Candidates who have not received equivalence for "Pre-Medical Group" in 12th grade examination from IBCC because they have studied and passed the subject of Mathematics instead of Physics or any other optional subject in their 11/12 grade, must submit the result card issued by the relevant board or university (e.g., Cambridge, American High School) along with their application, proving that they have studied and passed mandatory subjects of Biology and Chemistry in their 11th and/or 12th grades.

• Identity Documents:

- Identity documents include the Computerized National Identity Card (CNIC), National Identity Card for Overseas Pakistanis (NICOP), Pakistan Origin Card (POC), B-Form/ Child Registration Certificate (CRC), and Passport. The candidate must submit at least one of the aforementioned documents.
- ii. Along with the application form, the candidate must upload an identity document of one of the parents (Father/Mother).
- iii. Pakistani students residing abroad and holders of dual nationality applying for their reserved seats must upload one of the following documents:
 - Igama
 - Residence Permit
 - Green Card
 - Foreign Passport

Note: For candidates residing in Kingdom of Saudi Arabia (KSA), it is mandatory to submit a digital copy of their Iqama downloaded from the Absher or Ministry of Interior, KSA, official website, displaying the expiry date of the permit, along with the printed copy of their Iqama.

iv. Expired identity documents will not be accepted.

Special Documents:

These are the documents required specifically for applying to Quota Seats. They are not necessary for candidates applying solely on open merit.

- i. Candidates applying for reserved seats for Underdeveloped Districts must submit an Education Verification Certificate (a template is available on the UHS website) as proof that the candidate has obtained education from their respective district from the first class to the twelfth class. This certificate must bear the signatures and seals of the heads of all educational institutions (schools and colleges) from which the candidate got his/her education. The verification of this certificate shall be done by the respective Chief Executive Officer (District Education Authority) of Education (Colleges). Additionally, and Director attestation of this document by the Deputy Commissioner of the relevant district is also mandatory.
- ii. In addition to this Education Verification Certificate, these candidates must also upload their School Leaving Certificates/ Character Certificates/Provisional Certificates from their respective educational institution.
- iii. Candidates aspiring to apply for Cholistan's reserved seat must upload the Cholistan Development Authority-issued certificate (a template is available on

- the UHS website) as proof that the candidate is a Cholistani by birth and that his/her current place of residence is in Cholistan.
- iv. Candidates with physical disabilities applying for their reserved seats must submit a Disability Certificate issued by the National Council for Rehabilitation of Disabled Persons (NCRDP), Ministry of Social Welfare, or the Provincial/District Social Welfare Department. Based on this certificate, they shall be presented before a Medical Board, which will assess their eligibility for admission to medical/dental colleges.
- v. Candidates who are students of other provinces/regions shall provide domicile of their particular Province/Region.

• Photograph, Thumbprint, and Signature:

- i. The candidate must upload a recent photograph along with the admission form. The photograph should not be older than one month. It should be in color, with a white background, and the candidate's face must be clearly visible. Female candidates are allowed to wear a dupatta or headscarf, but their faces must not be covered. The photograph must not include caps, hats, or sunglasses. Candidates are instructed not to edit/touch-up their photographs.
- ii. The candidate has to sign on white paper with blue ink in running hand and also provide their left thumbprint. The photograph of this document should also be uploaded with the admission form

• Important Instructions for Digitizing Documents for Upload:

- i. Applications must be submitted online. Applicants must prepare scanned copies of all required documents in advance.
- ii. Each document must be in JPG/JPEG format, with a maximum file size of 1 MB per document. Applications such as CamScanner may be used for this purpose.
- iii. Only scanned copies of original documents shall be uploaded. Each document must be clear, legible, and free from blurs. Blurred or unclear documents will be rejected.
- iv. For double-sided documents, such as the CNIC, separate files for each side must be uploaded.
- v. Documents should be saved with unique file names and verified for accuracy before uploading.
- vi. If a document is in a language other than English or Urdu, an official notarized or certified English translation duly verified by the Embassy/High Commission of Pakistan in the respective country must also be provided

Important Rules and Regulation Related to Admissions

- i. The Admitting University shall have the power to review and rectify the merit/selection lists in case of any bonafide error, omission, lapse, mistake, fraud or misrepresentation that occurs or is brought to his notice at any stage of admissions.
- ii. Revision of result or improvement of marks by any Board/University after the closing date of submission of application shall not affect the merit list of admissions for the current year in any way. In other words, revised marks certificate shall not be acceptable after the closing date of submission of applications. Similarly, results declared after the closing date of submission of applications shall not be accepted for admission in the current session.
- iii. If considered necessary, the University may call any candidate for interview/investigation/enquiry at his/her own expenses
- iv. If a candidate already admitted in any medical/dental institution (public or private) of the country, gets admission in Government Medical & Dental Institution of the Punjab, he/she will have to surrender his/her previous admission completely and will not be entitled to any credit of examinations passed as well as dues paid prior to fresh admission
 - He/she must have valid MDCAT qualifying score.
 - He/she shall have to disclose his/her previous admission (template given as Annexure) at the time he/she reports at his/her college.
 - The candidate must not have exhausted all his/her chances to clear a professional examination and should be eligible to carry out further medical/dental education in Pakistan according to University Rules and Regulations.
 - Non-disclosure of previous admission shall result in cancellation of admission secured in the current session.
 - Under no circumstances a student will be allowed to rejoin the surrendered course.
- v. All admissions shall remain provisional till the closure of admissions for the current session.
- vi. The concerned college may refuse admission to any candidate who seems, for reasons to be recorded in each case at the time of interview, to be unsuitable or unlikely to become a good doctor. In case such a candidate is admitted, he/she can be struck off the rolls of the college, after issuing a notice to him/her to that effect.
- vii. All selected candidates shall have to deposit all original documents at the time of interview in the medical/dental college for which they have been selected along with attested copies of these documents. The signature and thumb impression of the concerned student on the back of attested copies of documents will be taken by

concerned college committee (to be constituted by the Principal). The original academic documents etc., will not be returned to the students until

- he/she has completed his/her MBBS/BDS education (after passing final year professional examination or otherwise);
- he/she has been debarred for further studies due to any reason.
- In case of cancellation of admission/studies due to bogus/fabricated documents, original documents shall not be returned to the candidate and shall only be handed over to police/investigating agency, if required, after taking qualified receipt.
- viii. The Medical Board of the respective medical colleges will examine selected candidates. If a candidate is disqualified medically, for reasons to be recorded, he/she will not be admitted. The Candidate must produce certificates to have been:
 - Inoculated against the enteric group of fevers within the preceding 12 months;
 - Fully vaccinated against Tetanus;
 - Fully vaccinated against hepatitis "B" virus;
 - Foreign students will have to produce a certificate of their HIV status from prescribed laboratories in Pakistan. If during the course of studies any student is found to be positive for HIV infection, he/she shall be repatriated at his/her own cost to his/her country of origin.
- ix. The parent(s) or legal guardians should accompany all the candidates at the time of interview.
- x. No candidate will be admitted unless he/she has paid the college fee. All dues must be paid by the due date, otherwise the admission of defaulting students will be cancelled and next candidate on merit will be considered for admission.

Eligibility Criteria for Admissions Against Quota Seats

1. Disability Quota

- a. The candidate must have fulfilled the mandatory eligibility criteria as stipulated by the Pakistan Medical and Dental Council.
- b. The candidate must have domicile of Punjab.
- c. The candidate shall have to attach a certificate from a government certified specialist about the nature of his/her disability. Such certificate, however, will only make him/her eligible to apply against the reserved seats.
- d. A Medical Board constituted by the Vice Chancellor of the University of Health Sciences shall make final decision about the eligibility of the candidate for admission against the reserved seats.
- e. The Medical Board shall consist of experts who will examine the candidate for physical disability, visual disability and hearing disability.
- f. Disability for the purpose of admission to medical and dental institutions is defined as "a physical impairment that has a substantial and permanent adverse effect on candidate's ability to carry out normal day-to-day activities and puts him/her at disadvantage as compared to a normal person for acquiring education before entering a medical or dental institution. However, the person is, otherwise, capable of completing his/her medical or dental education and perfuming his/her duties satisfactorily as a medical or dental practitioner later on. Here:
 - 'substantial' means neither minor nor severe; a person with minor or severe disability ineligible.
 - 'permanent' means that the effect of the impairment is likely to last for the rest of the person's life
 - 'normal day-to-day activities' include mobility, manual dexterity, speech, hearing, seeing, understanding danger, and memory.
- g. The threshold of disability will be judged by the Medical Board, according to a predefined, structured criterion.
- h. The Merit List of disabled candidates shall be finalized on the basis of *inter se* merit.
- i. The decision of the Medical Board shall be final.

2. Under-developed Districts

- i. The candidate must have fulfilled the mandatory eligibility criteria as stipulated by the Pakistan Medical and Dental Council.
- ii. The candidate must have a domicile of the same District Area.
- iii. The candidate must have studied, from class one to twelve, from the same district. He/she shall have to submit original certificates from Head Masters/ Principals of the concerned institutions where he/she has studied from class one to twelve. These certificates should be duly verified by the concerned EDO (District Education Authority) and Director of Education (Colleges), and countersigned by the Deputy Commissioner (DC) of the same district.

- iv. Candidates belonging to those tribal areas where there are no high schools or colleges available for the facility for teaching science subjects does not exist, they must have / obtained their education from Class-1 to Class-12 from the district in which their respective tribal area falls and have passed their SSC and HSSC examinations from the relevant Board of Intermediate and Secondary Education.
- v. The candidates from these areas can also apply against open merit seats. These reserved seats will be in addition to any number of candidates being admitted on open merit from these districts. The candidates from each of the above six districts, admitted or not admitted on open merit, can compete within their districts for reserved seats.
- vi. The merit list of candidates of under-developed districts will be displayed on district basis after ascertaining merit from amongst the candidates of the specific district subject to fulfillment of all other requirements and after verification of their documents from the concerned authorities.
- vii. Students admitted against these reserved seats from under-developed districts will be required to submit a Surety Bond at their respective college after admission on stamp paper duly attested for amount of Rs. 500,000/- and with an undertaking that he/she shall serve in his/her district of domicile for at least five years or in default thereof pay Rs. Five Lac in lump sum to the Government of the Punjab.
- viii. In case of Muzafargarh/ Kot addu, students of both districts shall be eligible to compete on these seats. Domicile and educational requirements as stated above shall apply mutatis mutandis.

3. ICT/ AJK/GB/EX-FATA And Balochistan (HEC Scholarship) Seats

- a) For all quotas excluding reciprocal seats, PTAP and IlOJK, the University of Health Sciences (UHS), Lahore shall accept applications directly from the students/candidates of ICT, Gilgit-Baltistan, AJ&K, ex-FATA, Balochistan (both categories of ex-FATA and Balochistan seats including the HEC scholarship seats) in accordance with the prescribed criteria for the respective seats and the list of selected candidates shall be vetted by the respective Provincial Governments/ HEC/ respective competent forum etc. UHS shall invite applications through public advertisement
- b) The candidates must fulfill the mandatory PMDC eligibility criteria.
- c) The candidates must have domicile of respective category.

4. Foreign Students Under Technical Assistance Program

a. The applicants seeking admission to medical/dental institutions of the Punjab under this category should submit their applications through their own governments/embassies to the Government of Pakistan (Economic Affairs Division, Islamabad) which will make necessary selection and allocation on the basis of Merit, Choice and Availability of seats.

- b. The nominations against these seats, shall be communicated to the Specialized Healthcare and Medical Education Department. Government of the Punjab, by Economic Affairs Division, Islamabad for onwards transmission to the concerned institutions.
- c. Applications submitted directly to the University or to the Government of the Punjab, shall not be entertained.

5. Overseas Quota

- a. The candidate must fall under the category of "foreign students" as per PM&DC Regulations.
- b. The candidate must hold a permanent foreign nationality or is an Overseas (being a Pakistani citizen permanently resident in foreign country) Pakistani, and who has studied and passed HSSC 12th grade examination or equivalent from outside Pakistan and is a resident of a foreign country at the time of applying for admission and possess a certificate from the institution last attended to this effect.
- c. The candidate seeking admission on these seats must fulfill the eligibility criteria as stipulated by the Pakistan Medical and Dental Council.

Integrated Modular Curriculum

The clinically oriented integrated modular curriculum at Rawalpindi Medical University (RMU) represents a significant shift from traditional medical education methods. This curriculum is designed to integrate basic and clinical sciences, promoting a holistic understanding of medicine through a student-centered approach. The key feature is its modular structure, where related topics from various disciplines are taught together, allowing students to appreciate their interconnectedness and clinical relevance.

Each module is organized around a specific system or theme, such as the cardiovascular or respiratory system, combining anatomy, physiology, pathology, and clinical medicine. This approach ensures that students can directly relate theoretical knowledge to practical scenarios. Early exposure to clinical settings is a hallmark of this curriculum, enabling students to interact with patients and apply their learning in real-world contexts from the beginning of their medical education.

The curriculum emphasizes active learning strategies, such as problem-based learning (PBL), case discussions, and small group activities, fostering critical thinking and teamwork. Assessments are also integrated, focusing on evaluating both knowledge and its application through multiple formats, including written exams, practical, and Objective Structured Clinical Examinations (OSCEs).

By aligning education with modern medical practices, RMU's integrated curriculum aims to produce well-rounded, competent physicians equipped to address complex healthcare challenges. This innovative approach not only enhances students' clinical acumen but also prepares them for lifelong learning, a vital trait in the ever-evolving field of medicine.

This modular system was introduced and successfully taught to first year batch 2017-18. Rawalpindi Medical University is the first public sector university in Punjab to take the initiative of developing and adopting the clinically oriented integrated modular curriculum successfully.

Advantages of Modular Curriculum

The examination system was also modified. Instead of an annual system of assessment there are more frequent modular assessments at the end of each module. The conventional methods of clinica examination have also been replaced by OSCE (objective structured clinical examination) which has eliminated subjectivity from the assessments.

Rigorous evaluation of curriculum reform and educational interventions will always be required if we are to be certain that we are doing the best that we can for our students and our patients.

Problem Based Learning Method at Rawalpindi Medical University - A Modern Teaching Strategy

Problem-Based Learning (PBL) is an instructional approach that uses complex, real-world problems as a platform for students to explore and understand concepts and principles, rather than relying on direct presentations of facts. This method not only delivers course content but also encourages the development of critical thinking, problem-solving, and communication skills. Additionally, PBL provides opportunities for collaborative work, research evaluation, and fostering a commitment to lifelong learning.

Rawalpindi Medical University (RMU) stands out as a pioneer among public sector medical colleges for adopting PBL as a core teaching methodology. Rooted in the principles of Adult Learning and Constructivism, PBL promotes critical thinking and empowers students to become self-directed, lifelong learners.

Disciplinary Policy

The Rawalpindi Medical University follows the same rules and regulations as specified by the Punjab Government. These can be found on the RMU Website or the student section. The

students are directed to follow these strictly, as some serious offences may even result in the expulsion of the student from the university.

"Ragging is strictly prohibited and the students taking part in it will be severely punished"

Discipline in Class Room

When the teacher enters his class room, the students should stand up and remain standing till they are directed to sit or till the teacher takes his seat. No pupil is allowed to leave the lecture room without the permission of his teacher or until the class is dismissed. Immediately after assembly of the class, the roll will be called and absence of any student noted. A student coming late into the class room will be marked absent unless his excuse is accepted by the teacher. Any student misbehaving in the class room shall at once be reported by the teacher to the Vice Chancellor, who will take such action as he may deem proper. Students are not permitted to remain in the lecture room except during the prescribed hours of lectures.

Discipline in Hospitals

Students attending hospital are required to abide by the hospital rules and while in the hospital are under the Vice Chancellor, for disciplinary purpose, which may impose any of the following punishments on any student committing any offence in the hospital or for neglect or not properly carrying out any duty entrusted to him/her in the hospital. Debar him/her from attending any or all the departments or hospital for a period not exceeding three months. OR Impose such fine not exceeding Rs. 500.00 as he may consider appropriate.

The same punishment and procedure will apply to the students for any offence done in the hospital as is applicable under OFFENCES and PUNISHMENTS.

Applications for leave from students doing duty in the hospital wards or out patients departments must be submitted through their respective medical officers to the Vice Chancellor of the university. Every student is required to attend punctually at the hours notified for clinical practice and ward duty.

Discipline in Class Examination

Students are not allowed to take into the examination hall text books, notes or manuscript of any kind. Any student found infringing the examination rules or having recourse to unfair means may be expelled from the examination and the matter shall be reported to the Vice Chancellor, who may refer his case for action to the university disciplinary committee. Late comers arriving at the examination hall more than 15 minutes after the start of the paper will not be allowed to enter the examination hall.

General Discipline

Students are required to observe order and discipline at all times in the university.

"Smoking within the university premises is strictly prohibited"

No game of any sort is to be played during the university and hospital duty hours.

- Displaying and distribution of partisan and political pamphlets or circulars etc., in the university and hospital premises are not allowed.
- All irregularities, neglect of duties and breaches of discipline are to be brought to the notice of the Vice Chancellor by the professors under whom the student is working.
- Every student to whom books or other property of government is entrusted shall be held responsible for their preservation in good condition and in the event of their being lost or damaged shall be required to replace them or repay their cost.
- Any student breaking or damaging any university property shall be required to pay the cost of repair or replacement.
- In case of willful damage, he shall be punished under the university disciplinary rules.
- If a student of the institution takes part in any political activity or conducts himself/herself in an unbecoming manner or in such manner as would interfere with the corporate life or educational work of the institution, the head of institution may take any action he deems proper or bring the matter before the Academic Council for proper action.
- No person shall be invited to address a meeting or society in the institution premises
 without prior permission of the head of the institution. In all cases, the chair shall be
 occupied by a responsible person approved for the purpose by the head of the institution.
 The subject of debate shall be fixed after obtaining the approval of the head of the
 institution in advance.
- No student shall address a Press Conference, nor write to the press on the political or related subject or matters concerned directly with the administration of the institution, University or any Government or Educational Institution in Pakistan or abroad. No poster or banner shall be put up without the approval of the head of the institution.
- No society may be set up by the students nor any meeting held in the institution premises without the written permission of the head of the institution.
- Riots, strikes, boycotts and demonstrations which create disturbance for other students or general public are not allowed.

Leave Policy

- All leave of absence from the university with the exception of sick leave will be without scholarship.
- Sick leave will only be granted on the production of a medical certificate from an authorized medical officer appointed by the Vice Chancellor of the university except when the student is already on leave out of station.
- In all cases leave taken will be at the student's own risk so far as the percentage of attendance is concerned and even medical certificate will not condone a deficiency in attendance.
- Students must not leave the station without the permission of the Vice Chancellor
- A student, who is absent without leave continuously for a period of four weeks, will be struck off the university roll.

Students Medical Certificate and Treatment

Students residing outside the university premises must obtain a medical certificate from a registered medical practitioner.

Students residing in the university premises including those on duty in the hospital, the medical certificate must be signed by a professor/associate professor / assistant professor of the university.

Medical certificate in support of absence must be produced at the earliest possible date and not weeks or months after the absence.

A medical certificate must specify the nature of the illness and the period with dates of leave recommended on account of that illness. Students who fall ill will be provided treatment on outdoor basis by a medical officer, specially assigned for this purpose. Medicine available in the hospital will be provided on the doctor's prescription. Student needing hospitalization will be entitled to the facilities of the general ward patients.

Books, etc.

Every student shall provide himself with all the prescribed text books and other necessary appliances

Correspondence

Students desirous of addressing the Vice Chancellor, by a letter must do so separately. Joint applications are entirely prohibited and will not receive attention. Any student wishing to make a representation on any subject has the right of direct access to the Vice Chancellor, at any time during the university hours. The Vice Chancellor, professors and other staff are accessible at any time for listening to the difficulties and grievances of students and shall always be pleased to advise them.

Hostel Policy

Admission to the Hostel

- The institutions are not bound to provide hostel accommodation to every student, however, accommodation will be provided subject to availability and according to the merit.
- ii. Hostel accommodation will be given to students seeking admission in the
- iii. medical, domiciled in places other than the city in which the institution is situated. Day scholars cannot apply except under special circumstances.
- iv. The head of the institution, on recommendations of the warden may refuse admission or reject the application of a student if he/she is satisfied that he/she is not a desirable person to live in the hostel.
- v. There are separate hostels for boys and girls. These hostels are open only to students on the respective college roll.

- vi. Seats shall be allotted by the warden in order of seniority and merit which will be determined by the year of study and by the marks obtained at the last University promotion examination. Failure in a class will be a discredit.
- vii. In making allotment the warden will also take into consideration the status of a boarder as well as his / her conducts and character.
- viii. Hostel allotment of students with outstanding dues is liable to cancellation.
- ix. Final year remanded students may be provided hostel accommodation subject to availability.
- x. No boarder is allowed to change his/her seat or accommodation without special permission of a warden concerned.
- xi. If a student who is allotted hostel accommodation is not personally residing and administration finds the misuse of the room i.e. keeping unlawful or illegal occupants, his/her allotment will be cancelled and the case will be referred to the Disciplinary Committee for further necessary action.

Hostel Fee & Subscription

The following hostel fee and utility charges are applicable to all public sector medical and dental colleges except Sargodha Medical College, University of Sargodha, and Nawaz Sharif Medical College, University of Gujarat. Hostel fee and subscription are payable by the students in advance for the full year along with the college fee:

Note:

- The student will be allowed to use electrical appliances like mini fridge, electric iron, microwave oven, and desert cooler, only with the permission of college authorities. Those who will be allowed to use these appliances will be charged extra for electricity as determined by the Academic Council of the institution from time to time. Unauthorized appliances will be confiscated and unauthorized use will be referred to the Disciplinary Committee for further necessary action.
- Students should not leave their room lights or fans, exhaust fans running, during their absence from their rooms. If reported upon, a fine of may be imposed for negligence.
- If the security deposited is not claimed within six months after leaving the hostel the same amount shall be credited to the common room fund.

Mess Rules

- Mess will be managed by the students under the supervision of the assistant warden. All boarders shall eat from the respective messes.
- Members may elect their own mess secretary, who will prepare a monthly mess menu in consultation with the warden and the students. Messing cost will depend upon the monthly mess menu and the market prices of the consumables. Messing charges for each month must be cleared by the 5th of subsequent month.
- Meals are served in the Dining Room and must not be taken in the living rooms.
- Members intending to skip a meal must notify the Mess Secretary / Mess Supervisor at least 12 hours before the meal time, otherwise they will be charged for it.
- Each student will deposit a sum of Rs.5000/- for in the Hostel office as mess security. Any student, who does not pay the mess security, will not be entertained.
- Mess security will be returned after adjusting the student accounts only when they finally leave the hostel.
- Members will pay expenditure of previous months before the 5th of every month after which the assistant warden with the permission of the warden may debar any student from the use of mess till the later has paid the expenses/plus a penalty of Rs.100/- per day.
- On return from vacations, members shall clear their accounts of the last working month
 within five days of their return to the hostel. Defaulters shall be liable to penalty
 prescribed above. The hostel clerks under the supervision of the warden will maintain the
 accounts.
- Members inviting guests should intimate their intentions to the mess supervisor at least
 12 hours before the meals are served to them.
- Only a bona-fide students will be eligible for mess membership.
- A member may lose his/her right or membership if his conduct is found unsatisfactory or if he does not abide by the rules of the mess but no member shall be dismissed without the sanction of the head of the institution.
- Self-cooking is not allowed in the hostels.

General Rules

- Fees and subscriptions once paid shall not be refunded in full or in part.
- The students failing to pay the required fee and subscription by the fixed date will be charged penalty of Rs.500/- per month (part of a month will be reckoned as full month) and shall be ejected from the college hostel if their accounts remain due for three successive months.
- If any student leaves the hostel without settlement of the hostel dues, the amount outstanding against him will be recovered from his security deposit and the student will be fined Rs. 5000/- in addition.

- The assistant warden is authorized to punish the boarder for any irregularity or breach in discipline by way of fine not exceeding Rs.2000/- for each violation of rules.
- Fines once levied will not be condoned.

Discipline

- The warden is responsible for maintenance of proper discipline in the hostel. He is authorized to punish students for any irregularities or breach of discipline. The warden may punish the students by way of a fine not exceeding Rs.5000/- for breach of discipline.
- Complaints by students proved to be correct after inquiry by the assistant warden shall be brought to the notice of the head of the institution for information to the parents of the boarders.
- Appeals against the orders of the assistant warden shall be made to the warden and those of the warden to the head of the institution.
- No gathering or meeting of boarders / non-boarders shall be allowed in the hostel premises in any case.
- No newspapers, periodicals, magazines, or any other publication other than those authorized by the head of the institution shall be brought into the hostels by any boarder.
- Every part of the hostel premises shall be open for inspection to the hostel and college authorities.
- Furniture must not be shifted from one room to another.
- All damages shall be repaired at the expense of the boarders responsible for the same.
- No religious ceremony likely to injure the feelings of other boarders shall be performed in the hostel.
- No boarder shall indulge in any amusement, which disturbs other boarders.
- Every boarder shall be in his room by 09:30 p.m. (except those who are on night duty in hospital). The assistant warden will go round the hostel at 09:30 p.m. to take the roll call of the students. Boarders are prohibited from leaving the hostel after 09:30 p.m. Any boarder, who wishes to stay out after this time, shall take prior permission from the warden. Latecomers after the roll call will first report to the assistant warden of their hostels before going to their rooms. Infringement to this rule is a serious offence. They have to fill the late coming form on register to explain reason.
- Applications for withdrawal from the hostel should be submitted to the warden.
- Any boarder found guilty of persistent violation of rules shall be expelled from the hostel by the warden.
- No boarder shall stay out for the night or spend the weekend without prior permission of the warden.
- Spitting in public or private rooms, verandahs or stairs is strictly prohibited.
- All waste papers and refuse must be placed in the receptacles provided for the purpose.
- Defacing walls and fixtures is strictly prohibited.

- All cases of sickness must be reported to the assistant warden at once for necessary action who may intimate the fact to the warden.
- Boarders are warned against interfering with the electric fittings.
- The use of liquor and other drugs of addiction in the hostel premises are strictly prohibited.
- Any kind of weapons are strictly prohibited. Defaulters shall be rusticated.
- Any student who is absent from hostel without permission for a period of more than one
 week, will automatically forfeit his allotment in hostel. Warden will open his room; store
 the belongings in the store room after making an inventory. The student on return will
 seek re-allotment of accommodation in the usual way.
- Any student who is unable to occupy his allotted seat in the hostel by the notified date for rooms, other than certified illness for which he will submit a certificate before the due date will also forfeit his allotment in the usual manner.
- No student is allowed to have any political affiliation. Any student involved in such activities is liable to be expelled from the hostel. No political gathering in the form of welcoming parties to new first year class in hostel is allowed.
- Ragging of first year students is not allowed.
- The hostel authorities will not be responsible for loss of anything from the student's room. But loss if any should by immediately reported to the assistant warden who may report to the warden. Students are advised not to keep a large sum of money or other costly items in the room.
- All the students are advised to take care or their belongings. In case of loss of any precious thing, hostel administration is not responsible.

Visitors

- Rights of admission to the hostel premises are reserved.
- No stranger shall be admitted inside the hostel premises without the permission of the warden.
- No guest shall be allowed to reside in the hostel. Violation of this rule will render the boarder liable for expulsion from the hostel in addition to any other penalty which the warden may deem fit.
- Boarders are not allowed to keep motor cycle/car in the hostel when the college and hospital are adjacent to the hostel. However, this can be allowed in special circumstances by the warden at the boarder's risk. The boarder will pay parking charges, i.e. bicycle: Rs.100/- per month, motorcycle: Rs.500/- month and Rs.1000/- per month for a motor car.
- The visitors will be seated in the reception room and the student concerned will be informed by the peon after the entry has been made in the visitor's book.
- No male visitors are allowed to enter the female hostel. Only those male visitors can be entertained in the reception room whose names are given in the visitor's list which has

been submitted in the hostel office duly signed by the parents or guardians of female students.

Special Rules for Female Students

- Parents or guardians are required to send a signed list of relatives who may visit their daughter.
- Students may receive authorized visitors from 5.00 p.m. to 8.00 p.m. At other times, visitors may be received only with the written permissions of the warden. The visitors will be seated in the reception room and will not be taken to living rooms.
- All applications for leave must be submitted to the warden, 24 hours before the date of leave.
- All students are required to take meals in the dining room. No student shall cook food in her room or bring food to her room.
- Free deliveries from restaurants or any other food item is only allowed till 9:00pm after their entry on colony's main gate.

Fee Policy

- The rate of fee given under "Fee & Subscriptions" is for current session only and shall be applicable to all categories of seats.
- The Punjab-domiciled candidates who will be selected for admission on Reciprocal seats in other Provinces/Regions will have to pay the remaining fee before they join the classes at their respective colleges.
- Newly selected candidates must pay their fee within the notified period. Failing to pay
 dues within the specified date and time, the candidate will lose his/her seat to the next
 candidate on the waiting list.
- A student who defaults in payment of tuition fee shall be liable to be expelled by the college subject to a reasonable period being granted to the student to remedy the defaulted fee.
- Only those students who are paying college dues will be considered as Bonafide students of the college.
- Students taking part in various sports clubs will pay additional subscription as fixed by the clubs.
- If the security deposited is not claimed within six months of leaving the institution, the amount shall be credited to the Students' Welfare/Benevolent Fund, which shall be used to help poor students.
- Unclaimed scholarships donated by agencies other than government shall be transferred to the Students' Welfare Fund after the expiry of one year period.
- A detained student shall be charged tuition fee in proportion to the number of failed subjects of that professional examination.

- The Academic Council of the institution may determine the rates of Students' Welfare Fund, Sports Fund, Magazine Fund and Mosque Fund, etc., according to the local conditions.
- Those students who avail the college transport will pay monthly charges in accordance with the rates as decided by the Academic Council of the institution from time to time.

Remission of Fee

- Remission of fee will be allowed by the Head of the Institution up to 10% of all students belonging to Punjab excluding remanded (including detained or expelled) students (two half fee concessions are equivalent to one full fee remission). Remission of fee means only tuition fee. No other fee or fund will be refunded.
- Remanded (including detained and expelled) students will not be entitled for fee concession.
- Applications for fee remission must be submitted by the candidates along with a statement stating the financial position of the applicant's parent/guardian and from the head of the department. Fresh applications will be required every year.
- The grant of such remission will rest with the Head of the institution and will depend upon the financial condition, general conduct, work and progress of the student. Absence from or failure in professional or house examination, breach of discipline, neglect of studies or irresponsible conduct shall entail the loss of the concession.

Refund of Fee

If a student after having obtained admission seeks to leave the programme, the college shall have the right to adjust the tuition fee already paid pro rata to the period spent by the student in the programme along with a penalty not exceeding ten percent of the total annual fee.

Student Counselling

Rawalpindi Medical University is unique in its student-centered approach. It is our aim to provide you with an environment which is conducive to your teaching and learning. However, medical school and studies can be very stressful. If you are having any problem getting in to the swing of things, you may communicate your issue to your assigned Group Facilitator or Student Liaison Officers of DME. Department of Medical Education provides our students with confidential counseling services, regarding future career planning as well as difficulties in studies. The student counselor will be available for interaction with the students at the RMU Old Teaching Campus on specified days. You are strongly recommended to avail these services for any problem you might be facing during your stay with us.

Orientation Week

The first few days of Medical University life can be confusing and daunting. Keeping this in mind, Rawalpindi Medical University has designed the first weeks' sessions as an orientation &

introduction to the medical University. You will be required to attend all the sessions as scheduled in the first week. Information can be obtained from the notice board or the DME.

Student Facilities

Libraries

There is a central library on the second floor of the RMU old campus building with the latest editions of all the Medical Text & Reference books on a wide variety of medical & paramedical topics. The university library also subscribes to leading international & national medical journals, review articles. The library timings are from 8.00 am to 2.30 pm, but steps are underway to increase the time till evening to aid students. Library membership card is free of cost, but Rs. 20/-





have to be paid, if lost. At a time, 2-3 books can be issued by one student, for a period of one month. After this period, the student has to get the book re-issued. There would be a fine of Re. 10/- per day after fifteen days have lapsed. Any damage/ loss to the books, while issued in the name of the student would be payable by the student.

The students have to get library cards issued from the library, once they have been registered and admitted in the college. The books can be issued on the library card. The students can avail this facility during their designated Self Directed Learning time.

The Holy Family Hospital and the Benazir Bhutto Hospital both have libraries for doctors and post-graduate trainees. These are open from 8.00 am till 7.00 pm, and can be availed for reference or general reading.

University Auditorium

It was inaugurated by General Muhammad Zia-ul-Haq (Former President of Pakistan) on 8th June, 1987. It is located in Old Campus of the university and is utilized for various purposes including recreational activities of students, conferences and seminars etc. It has a seating capacity of 1000 people.



RMU Sports Ground

A multi purpose ground exists in Old Campus. It is used for various purposes including sports activities, funfair, bookfair and annual dinner etc.

Skill Laboratory

It was established at New Teaching Block a few years back. It is basically meant to teach various skills to students via instruments and dummies. In our skill lab we teach obstetrical, gynecological and surgical procedures like cardiopulmonary resuscitation, intravenous cannula insertion, performing laryngoscopy etc.

Annual University Magazine 'SHIFA'

Students magazine Shifa is a stat of the art creation of RMU and it provides a platform to the students for their literary activities. Shifa magazine provides an opportunity to the student for writing fiction, poetry, comics, interviewing the celebrities and teachers. Shifa magazine also provides a pictorial voyage of various curricular and curricular activities of the students throughout the year. Literary society of the college compiles Shifa magazine and proof reading before publication is done by Patron in Chief.

Students' Journal of Rawalpindi Medical College (SJRMC)

The Students' Journal of Rawalpindi Medical College (SJRMC) is a student-led academic publication aimed at fostering research and academic growth among medical students. It provides a platform for showcasing original research, case reports, reviews, and medical insights. The journal encourages critical thinking and collaboration, promoting a culture of inquiry. SJRMC plays a pivotal role in enhancing the research capabilities and professional development of students at Rawalpindi Medical University, and is a testament of research culture at the institution.

Student Notice Boards

There are multiple notice boards around the university building. The students of first year are directed to check the main notice boards outside the Dissection Hall, Biochemistry Department, Physiology Department & Department of Medical Education regularly for information and updates. Venues for the teaching/learning sessions and the weekly timetable will be displayed accordingly, on these notice boards for the convenience of the students.

Cafeteria

Well stocked university cafeterias are located in both campuses. The students can avail the food services on payment. There are separate seating lounges for girls and boys. The cafeterias are open from 8.00 am to 2.00 pm.

Transport Services

The university provides transport facilities to its students to and from the hostels (girls & boys) and the teaching hospitals attached with Rawalpindi Medical University. The bus stand is located near the Latif Auditorium. The students should check the schedule of departure of buses by looking at the main student notice board. There is also bus service available for pick/ drop of students residing in Islamabad. This service is available on charge of Rs. 1500/- every month and seats are limited.

Hostels

For those students who have come from other cities to study at Rawalpindi Medical University may avail the hostel facilities provided by the university. There are 4 hostels currently available to the students for boarding purposes.

- Boys Hostel No. 1: University Premises near the Latif Auditorium, Main Campus, Tipu Road, Rawalpindi.
- Boys Hostel No. 2: National Market, Satellite Town, Rawalpindi.
- Girls Hostel No. 3: RMU Staff Colony, Rawal Road, Rawalpindi.
- Girls Hostel No. 4: RMU Staff Colony, Rawal Road, Rawalpindi.

The allotment of rooms is subject to availability and on first come first serve basis. Applications for Hostel Admission shall be submitted to the office of Warden Boys/ Girls Hostel. In case of approval of Hostel admission, the candidates are required to pay, within seven days of the approval, prescribed fees on prescribed payment form.

Failure in payment of fees may result in the cancellation of Hostel Allotment. In exceptional circumstances, Warden is empowered to extend the time for payment of Hostel fees up to four weeks. After payment of fees, the resident shall have to sign the terms of allotment describing the Hostel rules and regulation. Following which the resident can occupy the seat allotted to him/her. Messing and other amenities in the hostels may be availed on payment. Strict rules and regulations apply for residence in the hostel and students are directed to get a copy of these from the hostel clerk at the time of allotment.

NOTIFICATION

NO.SO(ME-II)2-1/2025: Pursuant to the approval of the Government of the Punjab/ Provincial Cabinet in its 29th meeting held on 06.10.2025 the Admission Policy for admissions to the MBBS/BDS Courses for the academic session 2025-26 in public and private sector Medical and Dental Colleges in Punjab is notified hereunder:

- 1. University of Health Sciences (UHS), Lahore, "Admitting University", shall conduct MDCAT and Central admissions to MBBS/ BDS courses of public and private sector Medical and Dental Institutions/ Colleges in Punjab for the Session 2025-2026.
- 2. The merit determination formula for the Session 2025-2026 shall be as under:

MDCAT	50% weightage
F.Sc (Pre-Medical)/HSSC/ Equivalent	40% weightage
Matriculation/ SSC/ Equivalent	10% weightage

3. The pass percentage and validity period of MDCAT shall be as under:

Examination	Course	Pass %	Validity Period
MDCAT	MBBS	55	Three years from the date
200	BDS	50	of conduct of MDCAT

*Candidates having domicile of Punjab shall appear in the MDCAT of Punjab.

- 4. The eligibility criteria for admissions shall be:
 - a. has passed the MDCAT Examination;
 - b. has obtained a Higher Secondary School Certificate (HSSC) qualification or an equivalent 12th grade qualification recognized in Pakistan (IBCC Equivalence Certificate is mandatory in that case) and having obtained minimum 65% marks therein; and
 - c. Has passed the subjects of Biology and Chemistry as mandatory and Physics or Mathematics as optional subjects in the examination of the Higher Secondary School Certificate Examination or an equivalent 12th grade qualification recognized in Pakistan.

*Provided that the mandatory requirement of MDCAT shall not apply to the candidates admitted on special program seat pre-defined exclusively for foreign students and on the seats reserved for Overseas (being a Pakistani citizen permanently resident in foreign country) Pakistanis, who have studied and passed HSSC 12 grade examination or equivalent from outside Pakistan. Such students shall qualify SAT-II with minimum score of 550 in each subject or a foreign MCAT examination or UCAT examination with 50% marks in each subject prescribed as stated supra in 4(c).

Hafiz-e-Quran Marks:

The marks for Hifz-e-Quran shall not be granted for admission to Medical and Dental Colleges in the light of PM&DC Medical and Dental Undergraduate Education (Admissions, Curriculum And Conduct) Policy and Regulations 2023 and the decision of six membered Bench vide Order dated 04.04.2023 in Suo-Moto case.

6. Students applying for admissions shall give an order of preferences for public and private sector Medical and Dental Colleges. In case of Private sector, there shall be no

restriction on the number of colleges to be opted by a candidate. In case of public sector, the applicant has to choose all colleges in order of preference. The application shall be editable till the closing date of submission; however; the number and order of preferences cannot be changed after last date of submission of on-line application. A college, not included in the preference list of student, shall not be considered for grant of admission / up-gradation.

- 7. Students admitted in private sector institutions may exercise the option to forego the right of up-gradation at the time of joining an institution. The option once availed shall attain finality and shall neither be revoked nor modified at any subsequent stage.
- 8. The admission process shall be conducted through an on-line portal. The University of Health Sciences (UHS), Lahore shall charge a fee of Rs. 2000/- from each candidate applying for admission to public and private sector Medical & Dental Colleges in Punjab. Each candidate shall apply separately to a medical or dental program. A student having not applied to a given program shall not be entitled to admission to such program. The selected candidate shall deposit prescribed college fee within three (03) working days after the display of the merit list. The University shall prepare college-wise selection list(s) in accordance with merit-cum-preference of candidates through a fair digitalized system developed/ acquired by the University. The following procedures shall be followed:

For Public Sector Colleges:

- a. Candidates shall deposit prescribed colleges fee in a dedicated bank account of the University (UHS), Lahore. In case of failure to deposit the prescribed admission fee within stipulated time period, such candidates shall have no vested right of admission in that year.
- b. Only those candidates shall be considered as admitted candidates who will "join" the program by (a) depositing the prescribed fee and other dues by due date, and (b) reporting (in writing) to their respective colleges by due date.
- c. The deposited fee will be disbursed by UHS, Lahore to the concerned colleges immediately after completion of admissions in designated bank accounts of concerned colleges by the UHS, Lahore.
- d. The overseas Pakistanis if selected against the open merit seats, then they shall pay fee at par with the Pakistani students. However, if they are selected against quota seats reserved for overseas Pakistanis then they shall deposit fee in foreign currency i.e. 10,000 US Dollars per annum on self-finance basis in accordance with the PMDC Notification PF-1-C-PMDC-Notification/2024/741 dated 21-03-2025. The students admitted under the category shall complete the entire program of study under the same category. An undertaking/ affidavit/ bond shall be provided by the student to this effect
- e. The students selected against foreign quota seats shall deposit fee in foreign currency i.e. 10,000 US dollars in accordance with the PMDC Notification PF-1-C-PMDC-Notification/2024/741 dated 21-03-2025. The students admitted under the category shall complete the entire program of study under the same category. An undertaking/ affidavit/ bond shall be provided by the student to this effect.

For Private Sector Colleges:

a. Upon display of name in the merit list, candidate shall deposit Rs.600,000/(6 lacs only) within three (03) working days after the display of the merit list in the designated account of UHS, Lahore to secure admission seat offered.

- b. Upon the display of the last merit list the remaining amount of admission fee shall be paid by the candidate directly at his/ her respective medical/ dental college in which he/she shall secure admission. The student shall have the right to pay the tuition fee on a quarterly, six monthly or annual basis to the college in line with the Medical and Dental Undergraduate Education (Admissions, Curriculum and Conduct) Policy and Regulations 2023.
- a. The deposited fee (Rs. 6 lacs only) will be disbursed by UHS, Lahore to the concerned colleges immediately after completion of admissions in designated bank accounts of concerned colleges by the UHS, Lahore.
- c. Candidates shall mark their Joining and give Consent for Up-gradation or Stay on the online portal of UHS. In the online Consent Form, candidates are required to indicate their choice from the following options:
 - i. Retain their allocated seat in the same college OR
 - ii. Opt for up-gradation as per merit and order of preference in the subsequent selection list.
- 9. The cut-off dates for receipt of nominations from Federal/ Provincial Governments and other Nominating Agencies/ Authorities for respective categories of seats shall be as under:

For all quotas excluding reciprocal seats, PTAP and IIOJK, the University of Health Sciences (UHS), Lahore shall accept applications directly from the students/ candidates of ICT, Gilgit-Baltistan, AJ&K, ex-FATA, Balochistan (both categories of ex-FATA and Balochistan seats including the HEC scholarship seats) in accordance with the prescribed criteria for the respective seats and the list of selected candidates shall be vetted by the respective Provincial Governments/ HEC/ respective competent forum etc.

11. Display of merit lists:

The admissions to public and private sector Medical & Dental Colleges shall be completed as per PM&DC schedule. The admissions in public and private sector Medical and Dental Colleges shall be completed after display of three or more merit lists by the University. The vacancies in second and subsequent merit lists shall be filled through the process of up-gradation, based on merit-cum-preference.

12. Number of Seats:

<u>A.</u> For public sector Medical and Dental Colleges, the admissions for the session 2025-26 shall be made on the following seats:

- i. In private sector medical and dental colleges, upto 15% of their total annual seats may be reserved for foreign students who fulfill the eligibility as stated supra in 4(c). However, where any seat of foreign quota remains vacant due to unavailability of eligible candidates or otherwise, it shall stand transferred to open merit and the student shall be charged fee and other dues prescribed for open merit seats. An ineligible candidate shall not be admitted against such seats.
- ii. Any increase in the number of seats, whether through the expansion of existing institutions or the establishment of a new medical or dental college, subsequent to the issuance of this Admission Policy, shall not be recognized or considered in the current academic session. Such cases shall be dealt in the next academic session.
- 13. The criteria for admissions against the quota seats in public sector Medical & Dental Colleges is placed at Annex-E. In addition, following criteria shall be applicable:
 - The candidates should fulfill the mandatory eligibility criteria as given above at Para 4.
 - b. For admission against seats reserved for Overseas Pakistanis students shall qualify MDCAT or in lieu of that SAT-II with minimum score of 550 in each subject or a foreign MCAT examination or UCAT examination with 50% marks in the subjects prescribed as stated supra in 4(c).
 - c. Students selected against overseas quota and foreign quota seats shall deposit fee in foreign currency i.e. US Dollars (\$ 10,000 USD per annum) in accordance with the PMDC notification PF-1-C-PMDC-Notification/2024/741 dated 21-03-2025. The students admitted under the category shall complete the entire program of study under the same category. An undertaking/bond shall be provided by the student to this effect.
- 14. Domicile of any district of Punjab is mandatory for admission to the following categories of seats in public sector Medical and Dental Colleges:
 - a. Open merit
 - Reserved seats for:
 - i. Disabled students;
 - ii. Cholistan;
 - iii. Under-Developed District;
 - iv. Reciprocal basis for Punjab candidates in other provinces
- 15. The vacant seats (seats left after cut off date of admissions as notified by PMDC) may be filled through upgradation. In case of exhausting of the eligible pool of candidates through upgradation, second chance for non-joiners (candidates whose name appeared in any of the merit list but he/she did not secure admission by deposit of fees) may be considered by the Provincial Admission Committee.



- 16. The Prospectus for Admission to Public sector Medical & Dental Colleges, Session 2025-26 shall be prepared by the University of Health Sciences. Lahore and shall be made available for the applicants on its website, www.uhs.edu.pk.
- 17. The tentative schedule for commencement of classes of public and private sector Medical & Dental Colleges of Punjab shall be as follows:

- 18. A Provincial Admission Committee, comprising the Vice Chancellors of all Public sector Medical Universities in Punjab, shall vet the selection list(s) before public display. The Secretary, SHC & ME Department shall be the Chairman of the said Committee.
- 19. In order to implement the admission policy for MBBS/BDS programs smoothly and to complete admission process in fair, transparent and efficient manner, the SHC&ME Department through Provincial Admission Committee is authorized as under:
 - a. To pass directions and taking decisions for admission process from time to time within the legal and notified parameters.
 - b. Issuing timelines/cut off dates for different steps of admission process and commencement of classes in accordance with PMDC guidelines/ notifications.
 - c. To adopt and implement notifications, guidelines of PMDC issued from time to time.

ANNEX-E

ELIGIBILITY CRITERIA FOR ADMISSIONS AGAINST QUOTA SEATS:

1. DISABILITY QUOTA:

- a. The candidate must have fulfilled the mandatory eligibility criteria as stipulated by the Pakistan Medical and Dental Council.
- b. The candidate must have domicile of Punjab.
- c. The candidate shall have to attach a certificate from a government certified specialist about the nature of his/her disability. Such certificate, however, will only make him/her eligible to apply against the reserved seats.
- d. A Medical Board constituted by the Vice Chancellor of the University shall make final decision about the eligibility of the candidate for admission against the reserved seats.
- e. The Medical Board shall consist of experts who will examine the candidate for physical disability, visual disability and hearing disability.
- f. Disability for the purpose of admission to medical and dental institutions is defined as "a physical impairment that has a substantial and permanent adverse effect on candidate's ability to carry out normal day-to-day activities and puts him/her at disadvantage as compared to a normal person for acquiring education before entering a medical or dental institution. However, the person is, otherwise, capable of completing his/her medical or dental education and perfuming his/her duties satisfactorily as a medical or dental practitioner later on. Here:
 - 'substantial' means neither minor nor severe; a person with minor or severe disability ineligible.
 - 'permanent' means that the effect of the impairment is likely to last for the rest of the person's life
 - 'normal day-to-day activities' include mobility, manual dexterity, speech, hearing, seeing, understanding danger, and memory.
- g. The threshold of disability will be judged by the Medical Board, according to a pre-defined, structured criterion.
- The Merit List of disabled candidates shall be finalized on the basis of inter se merit.
- i. The decision of the Medical Board shall be final.

2. UNDER-DEVELOPED DISTRICT

- The candidate must have fulfilled the mandatory eligibility criteria as stipulated by the Pakistan Medical and Dental Council.
- ii. The candidate must have a domicile of the same District/ Area.
- iii. The candidate must have studied, from class one to twelve, from the same district. He/she shall have to submit original certificates from Head Masters/ Principals of the concerned institutions where he/she has studied from class one to twelve. These certificates should be duly verified by the concerned EDO (District Education Authority) and Director of Education (Colleges), and countersigned by the Deputy Commissioner (DC) of the same district.
- iv. Candidates belonging to those tribal areas where there are no high schools or colleges available for the facility for teaching science subjects does not exist, they must have obtained their education from Class-1 to Class-12 from the district in which their respective tribal area falls and have passed their SSC and HSSC examinations from the relevant Board of Intermediate and Secondary Education.
- v. The candidates from these areas can also apply against open merit seats. These reserved seats will be in addition to any number of candidates being admitted on open merit from these districts. The candidates from each of the above six districts, admitted or not admitted on open merit, can compete within their districts for reserved seats.
- vi. The merit list of candidates of under-developed districts will be displayed on district basis after ascertaining merit from amongst the candidates of the specific district subject to fulfillment of all other requirements and after verification of their documents from the concerned authorities.
- vii. Students admitted against these reserved seats from under-developed districts will be required to submit a Surety Bond at their respective college after admission on stamp paper duly attested for amount of Rs. 500,000/- and with an undertaking that he/she shall serve in his/her district of domicile for at least five years or in default thereof pay Rs. Five Lac in lump sum to the Government of the Punjab.
- a) In case of Muzafargarh/ Kot addu, students of both districts shall be eligible to compete on these seats. Domicile and educational requirements as stated above shall apply mutatis mutandis.

3. CHOLISTAN SEAT

The Punjab Government approved reservation of one (01) seat for MBBS course (w.e.f. session 2010-11) for Cholistani students at Sheikh Zayed Medical College, Rahim Yar Khan, out of its current allocation on open merit basis with the following criteria:

- a) The candidate must have fulfilled the mandatory eligibility criteria as stipulated by the Pakistan Medical and Dental Council.
- b) The candidate has studied and passed HSSC from any of the districts Bahawalnagar, Bahawalpur or Rahim Yar Khan.
- c) The candidate must be Cholistani by birth and should have actual residence in Cholistan, as verified by Cholistan Development Authority. He/she shall have to provide a certificate with the application issued by the Cholistan Development Authority in this regard as per specimen provided in the Prospectus.

4. ICT/ AJK/GB/EX-FATA/BALOCHISTAN AND EX-FATA AND BALOCHISTAN (HEC SCHOLARSHIP) SEATS:

a) For all quotas excluding reciprocal seats, PTAP and IIOJK, the University of Health Sciences (UHS), Lahore shall accept applications directly from the students/ candidates of ICT, Gilgit-Baltistan, AJ&K, ex-FATA, Balochistan (both categories of ex-FATA and Balochistan seats including the HEC scholarship seats) in accordance with the prescribed criteria for the respective seats and the list of selected candidates shall be vetted by the respective Provincial Governments/ HEC/ respective competent forum etc. UHS shall invite applications through public advertisement.

- b) The candidates must fulfill the mandatory PMDC eligibility criteria.
- c) The candidates must have domicile of respective category.

5. FOREIGN STUDENTS UNDER TECHNICAL ASSISTANCE PROGRAM

- a) The applicants seeking admission to medical/dental institutions of the Punjab under this category should submit their applications through their own governments/embassies to the Government of Pakistan (Economic Affairs Division, Islamabad) which will make necessary selection and allocation on the basis of Merit, Choice and Availability of seats.
- b) The nominations against these seats, shall be communicated to the Specialized Healthcare and Medical Education Department. Government of the Punjab, by Economic Affairs Division, Islamabad for onwards transmission to the concerned institutions.
- Applications submitted directly to the University or to the Government of the Punjab, shall not be entertained.

6. OVERSEAS QUOTA

- The candidate must fall under the category of "foreign students" as per PM&DC Regulations.
- b) The candidate must hold a permanent foreign nationality or is an Overseas (being a Pakistani citizen permanently resident in foreign country) Pakistani, and who has studied and passed HSSC 12th grade examination or equivalent from outside Pakistan and is a resident of a foreign country at the time of applying for admission and possess a certificate from the institution last attended to this effect.
- c) The candidate seeking admission on these seats must fulfill the eligibility criteria as stipulated by the Pakistan Medical and Dental Council.
